We invite artists to explore this vibrant hue as the absolute dominant force in their work. Pieces can explore any shade, tint, or tone—from pale peach and burnt ochre to electric tangerine—but the visual impact must be unmistakably monochromatic.

All visual art mediums are welcome, including painting, sculpture, photography, digital art, mixed media, and more. Each artist may submit up to two pieces.
